Meter Reader

Classification: Full Time Status: Non-Exempt

Supervisor: Finance Manager or Designee

DESCRIPTION:

Responsible for ensuring accuracy of water meters through testing, calibrating and maintaining the meter change outs program. Monitoring and maintaining the fire hydrant flushing program. Maintains the pressure regulator maintenance and keeps accurate records.

ESSENTIAL FUNCTIONS:

- Installs and resets meter boxes and lids throughout the LRGPWWA Service Area ensures accessibility to Meter Readers
- Turns water service on and off as requested by customers or Customer Service
- Makes repairs and tests meters in the field and in the Meter Shop
- Aids in the investigation of customer problems; including leaks and high bills, conducts repairs and changes out water meters as necessary
- Replaces landscaping from repair damage that may occur; repairs or replaces broken curb stops
- Locates buried meters, reads meters when it is not possible for the Operators to gain access
- Acquires reads and locates meters
- Changes them out according to change out program; verifies meters are servicing correct addresses
- Maintains; tests and repairs water meters ranging from 3/4" to 10" in the field and Meter Shop
- Identifies water service line leaks to make the necessary repairs on the LRGPWWA side of the meter or communicates to the customer of leaks on the private side of meter
- Changes out water meters ranging from 3/4" to 2"
- Locates and raises buried meter boxes for Meter Reading to gain access
- Replaces old meter boxes and lids
- Assists in the installation and repair of post fire hydrants
- Responsible for the record keeping and flushing of routine and dead end water main fire hydrants in order to keep the fire hydrant flushing program current
- Assists in the installation and repair of large diameter pressure reducing valves
- Knowledge of procedure involved in responding to water quality complaint calls

- Monitors and maintains the fire hydrant flushing program including the routine and dead end water main fire hydrants in order to keep the fire hydrant flushing program current
- Installs, maintains and repairs post fire hydrants
- Safely operates a mini excavator and capable of training subordinates in its operation
- Utilizes a flow data logger and proper programming, installing and down loading procedures
- Programs and wires remote water meters in the distribution system
- Installs and repairs of large diameter pressure reducing valves
- Trains and influences staff in all safety practices and procedures
- May have respond to after-hours emergency calls

Additional Duties:

- Performs other duties as assigned
- On call is a requirement of this position

MINIMUM QUALIFICATIONS:

- High School Diploma or GED equivalent
- Three to Five years of experience as a Water Meter Mechanic
- New Mexico Level 3 water certification

The essential functions of this position are performed primarily outside; incumbent is exposed to fumes, gas, dust, noise and occasionally equipment vibration while performing duties.
